Tim Hortons Contest

Official Rules & Regulations

1) ENTRY PERIOD: The Contest begins at 12:00 pm on November 18, 2023 and ends at 11:59pm on November 20, 2023.

2) ELIGIBILITY: You must be thirteen (13) years or older and a legal resident in the province of British Columbia (BC) to enter this Contest. City of Surrey employees and immediate family members of City of Surrey employees are not eligible to enter.

3) HOW TO ENTER: You may enter by tagging a friend and follow @surreybcevents on Instagram or Surrey Tree Lighting Festival Facebook Page. Every tag will be counted as an entry.

This Contest is in no way sponsored, administered, or associated with Facebook, Inc. or Instagram Inc. By entering, entrants confirm that they are 13+ years of age, release Facebook and Instagram of responsibility, and agree to Facebook and Instagram's terms of use.

4) ENTRY GUIDELINES:

Comments (including photos) must be either your own work or submitted with the consent of the creator. Previously published material for which non-exclusive rights were granted may be entered as long as you still maintain the right to grant us a license. You are responsible for obtaining, prior to submitting any entry, any releases and consents necessary to permit the exhibition and use of the entry in the manner described in these Official Rules without additional compensation.

If any person appearing in any photo or video is under the age of majority in their province of residence the signature of a parent or legal guardian is required on each release.

5) PRIZES: There is one (1) Grand Prize Winner. The Winner will receive a \$100 gift card to Tim Hortons.

The Prize must be accepted as awarded and is non-transferable. No substitution of the Prize is permitted. The Prize cannot be returned for a cash refund.

6) WINNERS AND ODDS: One (1) Grand Prize Winner will be drawn after November 20, 2023 but before November 25, 2023, from all eligible entries received.
