Official Rules & Regulations

1) ENTRY PERIOD: The Contest begins at 12:00 noon on November 19, 2022 and ends at 11:59pm on November 19, 2022.

2) ELIGIBILITY: You must be thirteen (13) years or older and a legal resident in the province of British Columbia (BC) to enter this Contest. City of Surrey employees and immediate family members of City of Surrey employees are not eligible to enter.

3) HOW TO ENTER: You may enter by posting a picture or video of your food purchase at the event on Instagram or Facebook using the hashtag #SurreyTreeLighting AND tagging @surreybcevents on Instagram or Surrey Tree Lighting Facebook Page.

You will receive one (1) entry for every distinct picture or video of your food purchase that you post and tag in the manner described above. Unlimited entries are allowed.

This Contest is in no way sponsored, administered, or associated with Facebook, Inc. or Instagram Inc. By entering, entrants confirm that they are 13+ years of age, release Facebook and Instagram of responsibility, and agree to Facebook and Instagram's terms of use.

4) ENTRY GUIDELINES: Comments (including photos) must be either your own work or submitted with the consent of the creator. Previously published material for which non-exclusive rights were granted may be entered as long as you still maintain the right to grant us a license. You are responsible for obtaining, prior to submitting any entry, any releases and consents necessary to permit the exhibition and use of the entry in the manner described in these Official Rules without additional compensation.

If any person appearing in any photo or video is under the age of majority in their province of residence the signature of a parent or legal guardian is required on each release.

Entries must be in English. Late or corrupt entries will not be accepted. Your entries must not be obscene or otherwise inappropriate, as determined by the City of Surrey in its sole discretion. Entries that are deemed inappropriate will not be accepted.

5) PRIZES: There will be one (1) Grand Prize Winner. The Winner will receive a gift card to Guildford Town Centre having a face value of \$100.
