- **1) ENTRY PERIOD:** The Contest begins at 12:00 noon on November 19, 2022 and ends at 11:59pm on November 19, 2022.
- **2) ELIGIBILITY**: You must be thirteen (13) years or older and a legal resident in the province of British Columbia (BC) to enter this Contest. City of Surrey employees and immediate family members of City of Surrey employees are not eligible to enter.
